2015 ASSEMBLY BILL 893

February 9, 2016 – Introduced by Representatives SUBECK, BERCEAU, JOHNSON, SINICKI, C. TAYLOR and ZEPNICK. Referred to Committee on Criminal Justice and Public Safety.

AUTHORS SUBJECT TO CHANGE

1 AN ACT to renumber and amend 941.29 (4); to amend 941.29 (1g) (a), 941.291 2 (1) (b) and 973.123 (1); and to create 941.29 (4) (b) of the statutes; relating to: 3 storage of a firearm in a house in which a resident is prohibited from possessing 4 a firearm and providing a criminal penalty.

Analysis by the Legislative Reference Bureau

This bill requires a person to store any firearm he or she possesses in a securely locked box or container or other secure locked location or with a trigger lock engaged if the person resides with a person who is prohibited from possessing a firearm under state law. A person who violates this requirement is guilty of a Class A misdemeanor for a first offense and a Class I felony for a second or subsequent offense.
