AUTHORS SUBJECT TO CHANGE

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 5, line 1: delete the material beginning with that line and ending
3 with page 8, line 5.

4 **2.** Page 9, line 10: after “941.235” insert “(2m) (a)”.

5 **3.** Page 13, line 13: delete that line and substitute “renumbered 941.235 (2m)
6 (a) 1., 2., 3., 4., 5., 6. and 7.”.

7 **4.** Page 13, line 14: delete “, 1. and 2.” and substitute “and 1.”.

8 **5.** Page 13, line 15: delete that line and substitute “941.235 (2m) (c) (intro.)
9 and 1.”.

10 **6.** Page 13, line 16: delete lines 16 to 20 and substitute:

1 “**SECTION 48m.** 175.60 (16) (b) 2. of the statutes is renumbered 941.235 (2m)
2 (c) 2. and amended to read:”.

3 **7.** Page 13, line 21: delete “(b)” and substitute “941.235 **(2m)** (c) 2.”.

4 **8.** Page 14, line 9: delete lines 9 to 18.

5 **9.** Page 17, line 15: delete lines 15 and 16 and substitute:

6 “**SECTION 60g.** 941.235 (title) of the statutes is amended to read:

7 **941.235** (title) **Carrying firearm in public building and other**
8 **prohibited places.**

9 **SECTION 60i.** 941.235 of the statutes is renumbered 941.235 (1m) and
10 941.235 (1m) (b) (intro.), 1., 3. and 4., as renumbered, are amended to read:

11 941.235 **(1m)** (b) (intro.) This ~~section~~ subsection does not apply to any of the
12 following:

13 1. Peace officers or armed forces or military personnel who go armed in the
14 line of duty or to any person duly authorized by the chief of police of any city, village
15 or town, the chief of the capitol police, or the sheriff of any county to possess a
16 firearm in any building under ~~sub. (1) par. (a).~~ par. (a). Notwithstanding s. 939.22 (22), for
17 purposes of this ~~paragraph~~ subdivision, peace officer does not include a commission
18 warden who is not a state-certified commission warden.

19 3. A qualified out-of-state law enforcement officer, ~~as defined in s. 941.23 (1)~~
20 ~~(g), to whom s. 941.23 (2) (b) 1. to 3. applies~~ who is in compliance with 18 USC 926B.

21 4. A former law enforcement officer, ~~as defined in s. 941.23 (1) (e), to whom s.~~
22 ~~941.23 (2) (e) 1. to 7. applies~~ who is in compliance with 18 USC 926C.

23 **SECTION 60k.** 941.235 (2m) of the statutes is created to read:

1 941.235 (2m) (a) No person may go armed”.

2 **10.** Page 17, line 18: delete “(h)” and substitute “8.”.

3 **11.** Page 17, line 20: delete “(i)” and substitute “9.”.

4 **12.** Page 17, line 22: delete “(2)” and substitute “(b)”.

5 **13.** Page 17, line 22: delete “sub. (1)” and substitute “par. (a)”.
