24 (k) Notwithstanding W.S. 6-8-105 and 6-8-401(c), the board of
25 trustees in each school district may adopt rules and regulations,
26 in consultation with local law enforcement if necessary, to
27 prohibit the possession or carrying of firearms by all persons on

29 district. Any rules or regulations adopted under this subsection

13 or in any property or facility owned or leased by the community
14 college district. Any rules or regulations adopted under this
15 section prohibiting the carrying or possession of firearms shall
16 apply to all employees, students and persons.". KOST
